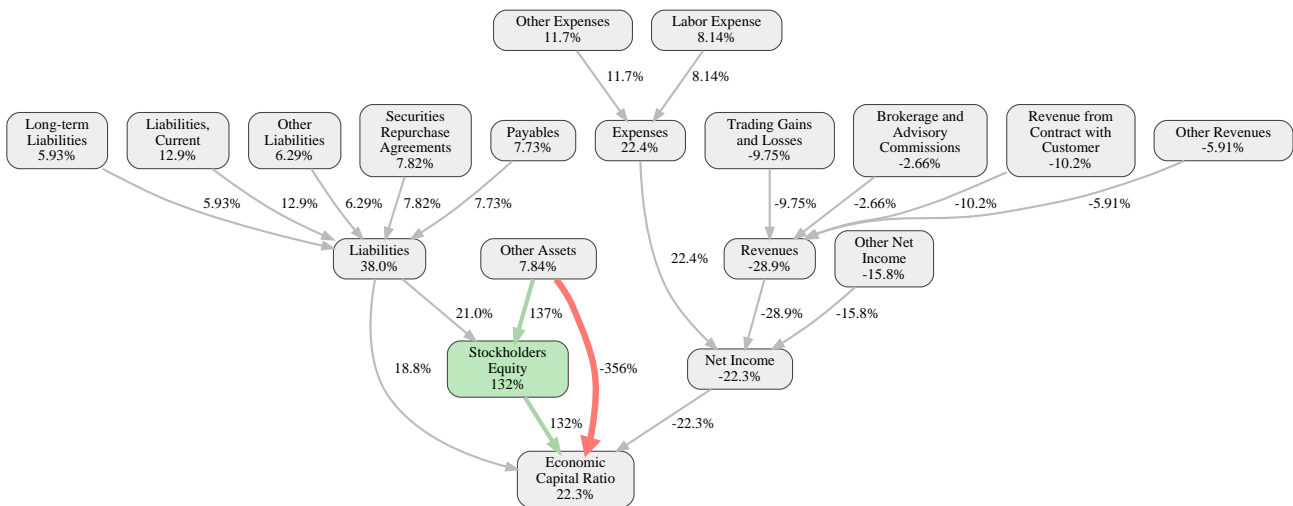

## Invesco CurrencyShares Australian Dollar Trust Rank 33 of 74



The relative strengths and weaknesses of Invesco CurrencyShares Australian Dollar Trust are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Invesco CurrencyShares Australian Dollar Trust compared to the market average is the variable Expenses, increasing the Economic Capital Ratio by 22% points. The greatest weakness of Invesco CurrencyShares Australian Dollar Trust is the variable Revenues, reducing the Economic Capital Ratio by 29% points.

The company's Economic Capital Ratio, given in the ranking table, is 215%, being 22% points above the market average of 193%.
