

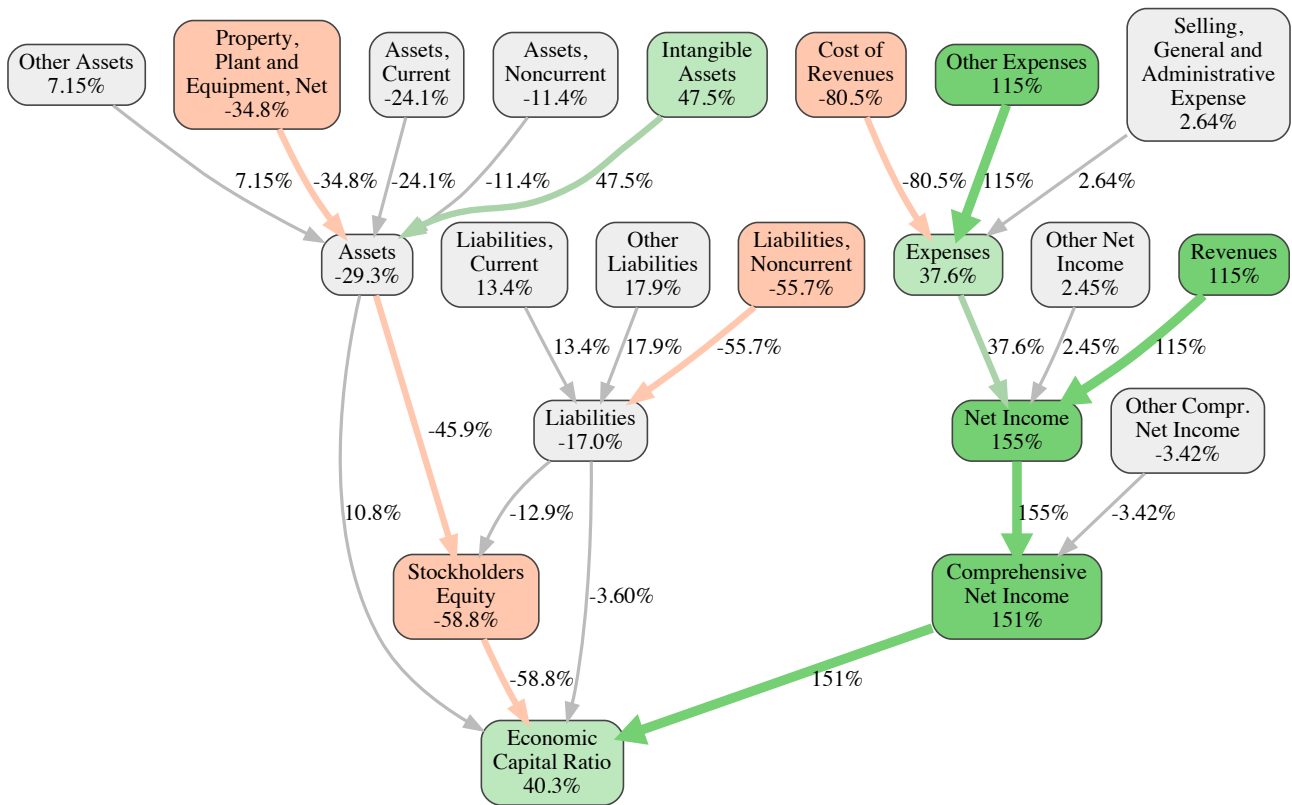

The relative strengths and weaknesses of NEWELL BRANDS INC. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of NEWELL BRANDS INC. compared to the market average is the variable Net Income, increasing the Economic Capital Ratio by 164% points. The greatest weakness of NEWELL BRANDS INC. is the variable Cost of Revenues, reducing the Economic Capital Ratio by 89% points.

The company's Economic Capital Ratio, given in the ranking table, is 86%, being 15% points above the market average of 70%.
