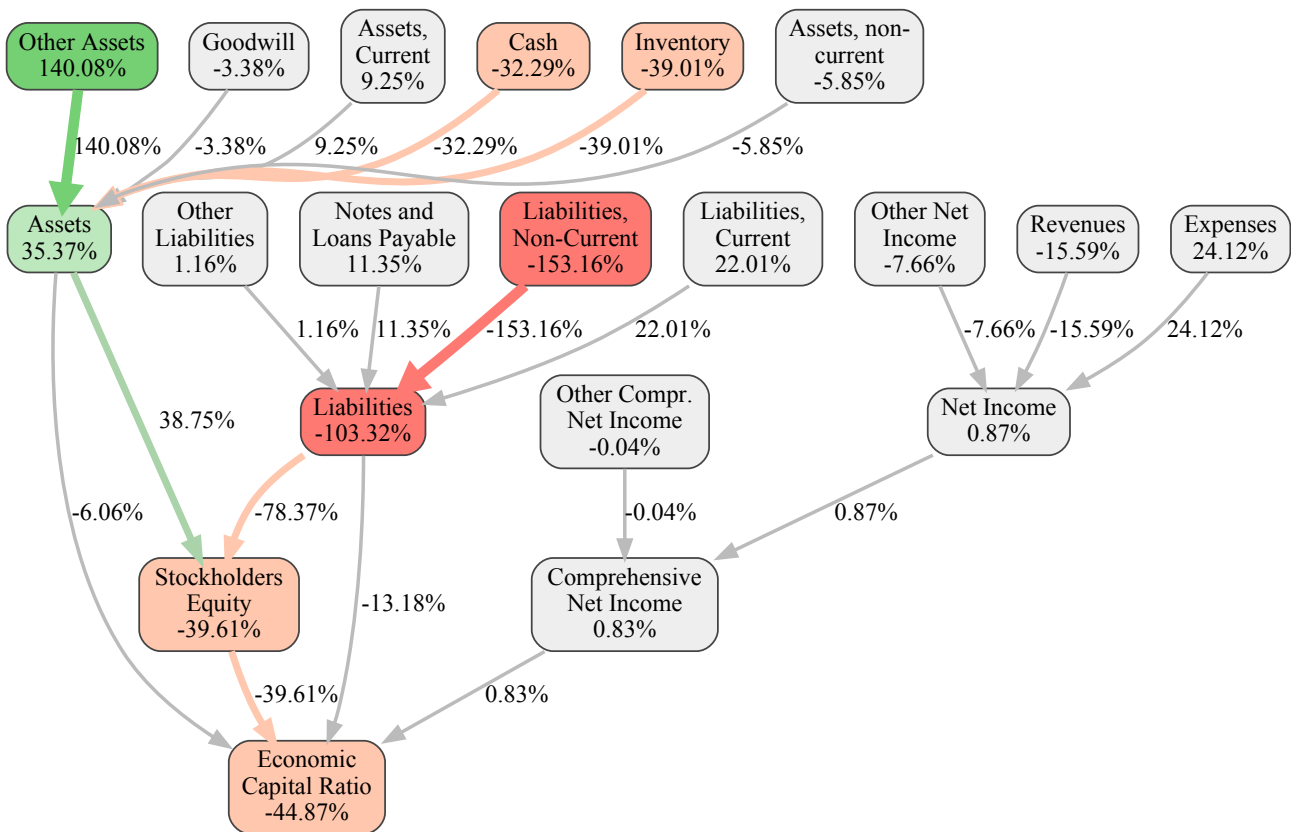

The relative strengths and weaknesses of Great Lakes Dredge & Dock CORP are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Great Lakes Dredge & Dock CORP compared to the market average is the variable Other Assets, increasing the Economic Capital Ratio by 140% points. The greatest weakness of Great Lakes Dredge & Dock CORP is the variable Liabilities, Non-Current, reducing the Economic Capital Ratio by 153% points.

The company's Economic Capital Ratio, given in the ranking table, is 88%, being 45% points below the market average of 133%.
